



# FINE RETURNS FROM FINE WINES

## WINE INVESTMENT PHILOSOPHY

Research shows that fine wine prices rise by an average of approximately 15.5% per year. This results from the unique supply and demand dynamics of this asset class: the supply of any particular wine can only reduce as it is consumed; meanwhile, because fine wine improves with age, demand naturally increases. Increased demand has also, more recently, come from the rise in consumption by the new wealthy classes in emerging markets.

Performance has not come with higher risk. Volatility measures show that fine wine is actually less risky than equities, gold and oil. If you compare returns per unit of risk, wine significantly outperforms these other assets. A number of studies have found very low or even negative correlation between fine wine returns and those of other assets.



The Wine Investment Fund is the leading fine wine fund because it has a clear and articulated investment philosophy operated by skilled and experienced investment managers who apply equity-style analysis to the fine wine market.

Assets are independently and transparently priced by Liv-ex, the fine wine exchange. The Fund also operates with a high degree of security, holding all stock in a UK government bonded warehouse, licensed and policed by the UK customs authority. Finally, it is the longest established publically offered fine wine fund with an exemplary performance record (average of 13.8% per annum paid-out, net of all fees and expenses).
